1. Health & Medical Disclosure

[✓] Medical Disclosure: I confirm that I have disclosed all known medical conditions, injuries, sensory triggers, physical limits, and behavioral/developmental needs for my child. I agree to notify Charlie Mike staff immediately of any changes.

[✓] Emergency Authority: In an emergency where I cannot be reached, I authorize staff to seek necessary medical treatment or transport for my child.

2. Arrival, Attendance & School Transition

[✓] Arrival Protocol: I understand sessions are designed to support a smooth transition into the school day. I agree to have my child arrive 10 minutes prior to class start time to settle in and prepare. While lateness is not penalised, I understand consistent routine supports engagement and safety.

[✓] Post-Class Transition: I understand that at the conclusion of the morning session, children transition directly onto school grounds/into their regular school day. No parent pick-up is required immediately following the class.

3. Media Release & Marketing Permissions

[✓] Media Release Permission: I acknowledge that media permissions (photos, audio, and video for marketing, promotional, educational, and digital use, including systemsforlife.com.au) are managed directly via promotional discount codes applied at online checkout.

4. Fee Commitment, Absences & NDIS Billing

[✓] Program Fees: Program fees are determined by the specific tier, session frequency, or billing agreement selected at online checkout.

[✓] NDIS & Third-Party Billing: For participants utilizing Self-Managed or Plan-Managed NDIS funding, tax invoices will be issued in accordance with standard Capacity Building support line items. The parent/guardian remains ultimately responsible for ensuring accounts are settled in full.

[✓] Refunds & Cancellations: Enrollment fees secure a dedicated participant position in the designated group block. Missed individual sessions or voluntary absences are non-refundable and non-transferable, except where required under Australian Consumer Law or agreed upon in writing prior to term commencement.

[✓] NDIS Balance Responsibility: I understand that I remain responsible for account balances if NDIS claims are delayed, rejected, or exhausted.

5. Program Suitability & Right Fit Policy

[✓] Evaluation Period: I understand the first 2–3 sessions serve as an evaluation period for mutual fit, safety, and group dynamic.

[✓] Discontinuation Policy: If enrollment is discontinued by Systems for Life due to safety or behavioral fit, unused prepaid fees will be refunded pro-rata.

6. Safety & Physical Risk Acknowledgement
